## Telephone AutoPatch Returns to Harrisonburg/Rockingham

Many hams have expressed interest in an autopatch to access telephones in Harrisonburg and Rockingham County. An autopatch allows hams to make phone calls via 2-meter ham radio.

As this issue goes to press, a group of local amateurs are putting the finishing touches on an autopatch system to meet this demand.

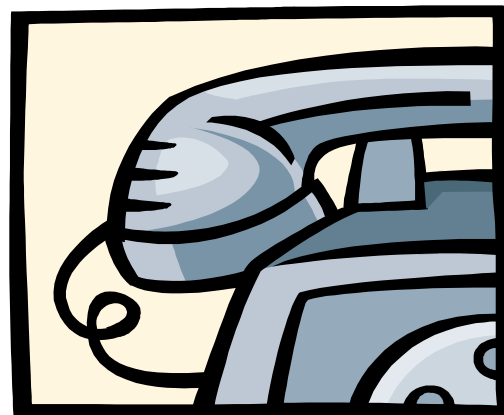
However, the system is not a normal repeater autopatch. It has some special operating characteristics. For example, on this system, the radio amateur cannot override the phone audio by pressing the mike key. The ham can actually "double" with the telephone audio if (s)he is not careful. Also, the ham user must wait until the dial tone drops out (yep, drops out!) before dialing the number.

The patch requires a dedicated telephone line. This means that someone has to pay a monthly



phone bill. To help offset the cost, users of the patch are asked to subscribe for \$15 per year. For the \$15 per year, you get unlimited calls to the local calling area, which includes all of Rockingham County (from Grottoes to Bergton), as well as small portions of Augusta and Page counties. For families with more than one ham, a family rate of \$25 is available.

## Great North Mountain 444.600(+) Repeater Up and Running

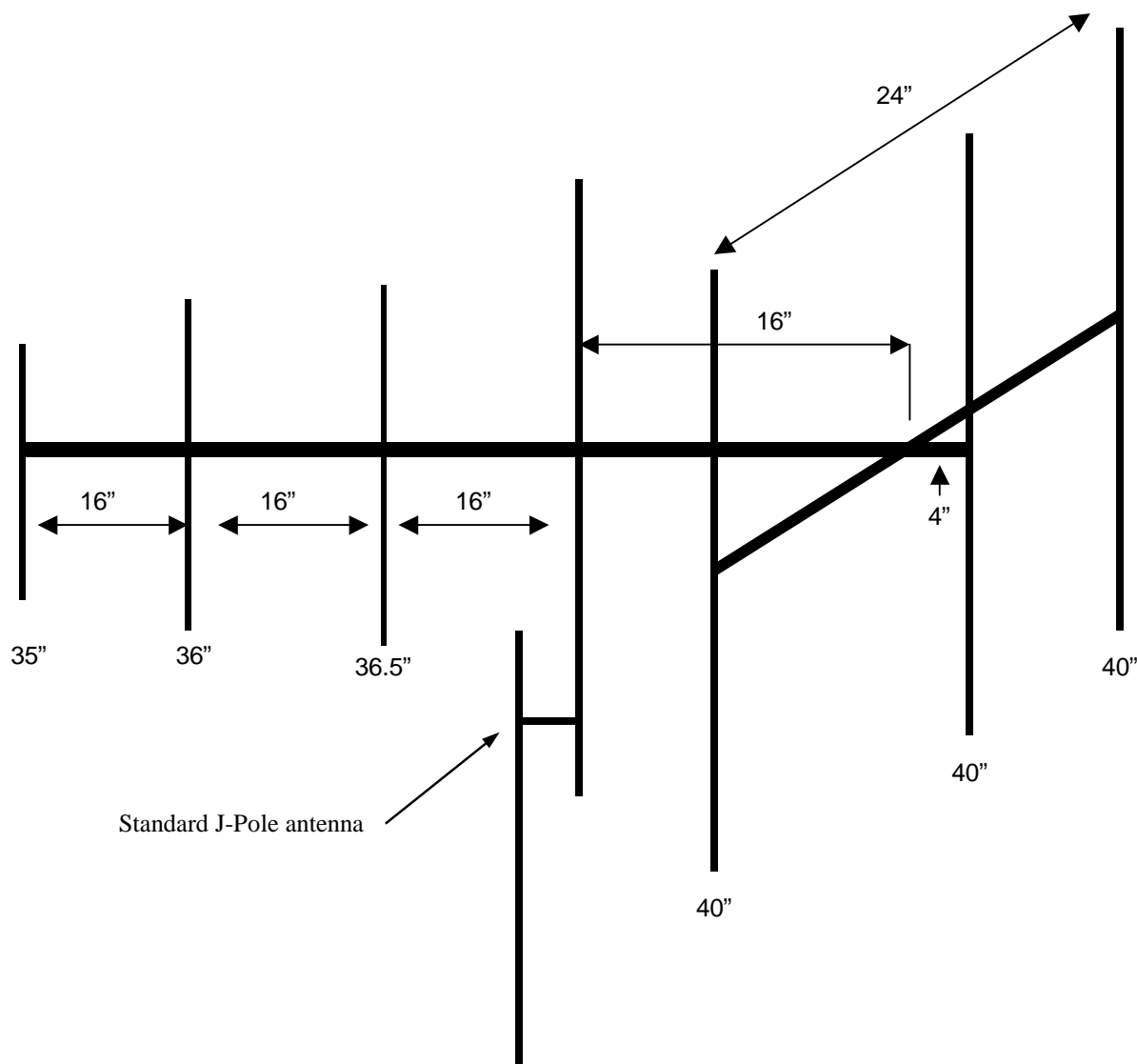
The machine is on 444.600 MHz, with an input frequency up 5 MHz.

The machine provides good access from Rockingham and Shenandoah Counties, and can be worked from a handi-talkie from most anywhere west of the Massanutten range. ## Homemade J-Pole Yagi for 2-meters

## Field Day Planning Underway

Each year, on the last full weekend in June, radio amateurs around the world leave their radio shacks. They unplug from the commercial electrical system, and operate completely on emergency power.

Known as "Field Day", the event is a demonstration of the communications capabilities amateurs can provide in case the national power grid is disrupted. (Hey, look at California these last few months!)

Hams in the valley travel up into the mountains west of Dayton for a week of camping, fellowship, and preparations.

Then, on Field Day Saturday, ham radio stations are put together in less than 12 hours, including emergency power sources. The hams operate 24 hours straight, proving that nationwide (or even worldwide) communications can take place without the benefit of commercial electricity.

Ray Colvin, KE4HVR, reports that a Virginia Assembly Bill 1884 was killed before leaving committee. The bill was aimed at prohibiting cell phone calls from distracting drivers on the highways.

However, as it was worded, it also would have interfered with operation of almost all wireless and radio equipment in a vehicle, including police, fire, and amateur radio operations.

Many hams joined forces with other agencies in notifying the state legislators of the flaws in the bill's wording. Thanks to those who wrote.

## Oscillating Pre-Amps Generate Rash of RFI Complaints

The FCC reports it's gotten word of a rash of interference problems created by oscillating pre-amplifiers built into Winegard TV antennas. These antennas are used primarily on RVs, campers and motor homes. The oscillations generally appear in the 400-500 MHz range--and sometimes elsewhere--and have caused interference problems to public safety and Amateur Radio operation at dis-

tances of several miles away. The FCC's Gary Hendrickson says Winegard has acknowledged the problem and estimates that there may be as many as 40,000 defective units in the field, which it has agreed to replace at no charge. Owners, RV dealers or repair shops that might have new, but defective, units in stock should contact the factory at Burlington, Iowa, at 319-754-0600. Wine-

gard also has proposed a proactive program in which service technicians will visit the larger campgrounds, rallies and dealers around the country, actively look for defective/radiating units in operation or on the dealer's shelves, and replace them at no charge to the customer, regardless of the age of the unit.
